12.08.01 Contract authorized That the Mayor and City Clerk of the city of Heber Springs, Arkansas, are hereby authorized to enter into a contract with the Optimist Club of Heber Springs, and Arkansas non-profit corporation, for the provision of Sports programs for the youth of the City. (Ord. No. 96-1, Sec. 1.)

12.08.02 Optimist Club duties The Optimist Club of Heber Springs shall provide the facilities for and the administration of soccer, basketball and baseball programs for the youth of the city. (Ord. No. 96-1, Sec. 2.)

12.08.03 Payment As and for the consideration for this contract, the city of Heber Springs agrees to pay, and the Optimist Club of Heber Springs agrees to accept, the sum of None Thousand Nine Hundred Ninety-five Dollars (\$9,995.00) (Ord. No. 96-1, Sec. 3.)

12.08.04 Contract term The term of this contract shall begin upon the date of passage of this ordinance, and acceptance thereof by the Optimist Club of Heber Springs, and end upon December 31, 1996. (Ord. No. 96-1, Sec. 4.)
